

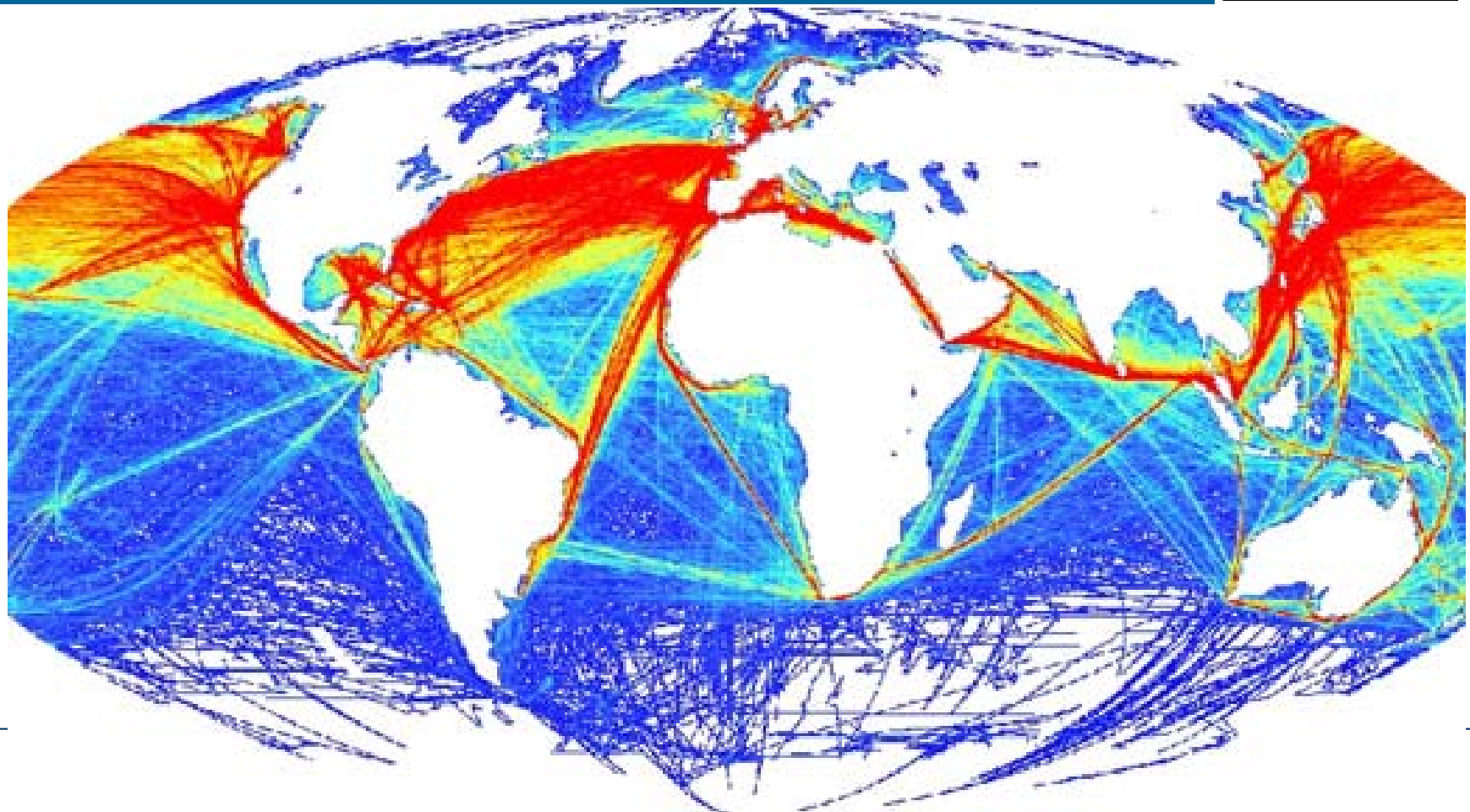

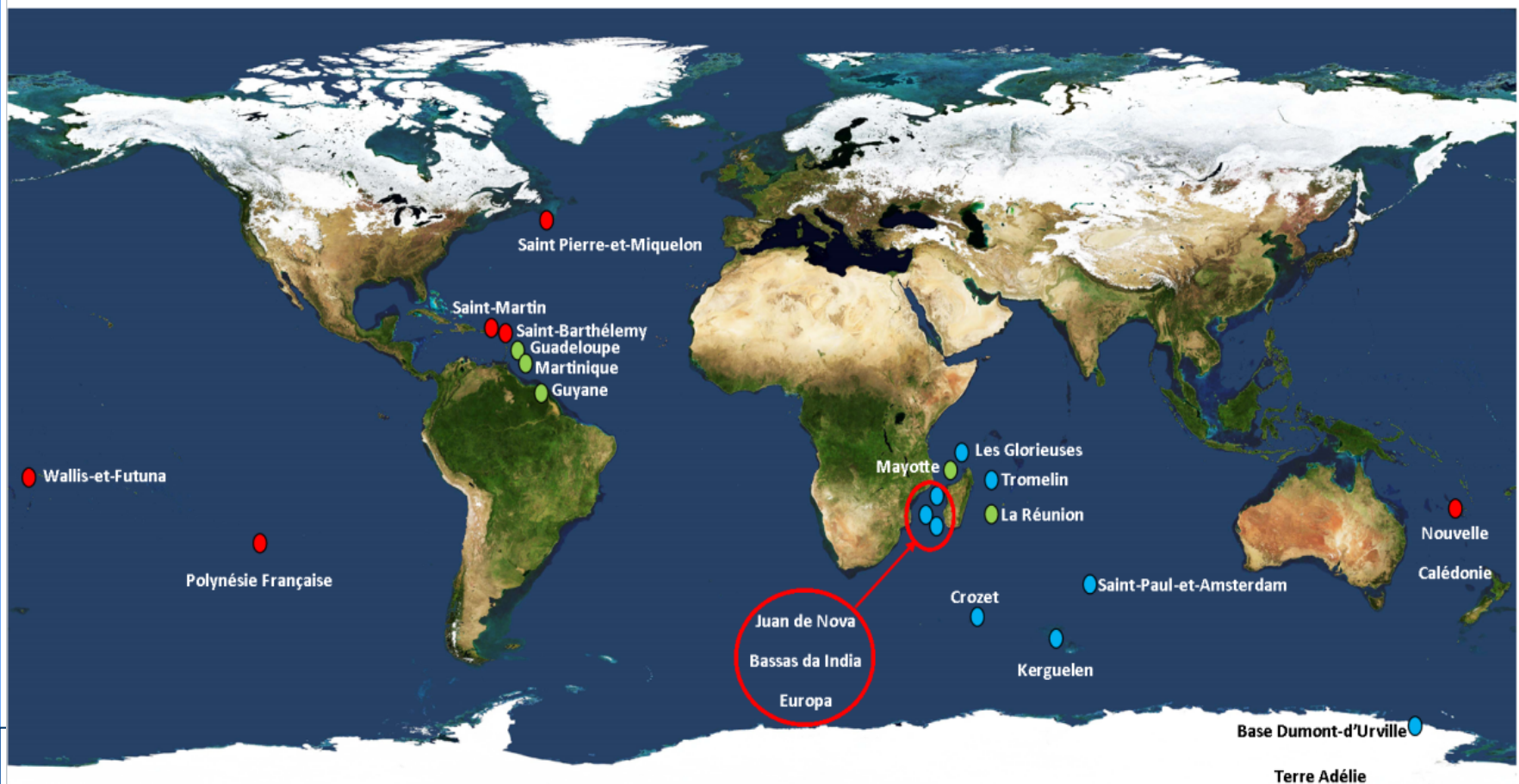

French Government Ministries with interests at Sea

- Environnement, Energy and the Sea
 - Foreign Affairs and International Development
 - Overseas departments
 - Defence
 - Interior
 - Justice
 - National Education, Higher education & Research
- ⇒ Need for a body to coordonate: the SGMer
= maritime governance (Safety, Security, developpement)
- *coordinating and following the outcomes of maritime policy ;*
 - *coordinating State Action at Sea & the coast guard function.*

the State Action at Sea

A single authority :

- ***at central level : Secretariat general for the Sea ;***
- ***at Sea : the Maritime Prefects
+ State delegates Overseas.***

- ***A maritime zone.***

- ***Several identified missions.***

- ***Pooling of resources'
phylosophy within the
government administrations.***



The Actors of State Action at Sea

Main national authorities enforcing law at sea :

- **Navy (and Maritime Gendarmerie)**
- **Customs**
- **National Police**
- **Maritime Affairs**
- **Civil Safety**



Each administration is responsible for implementing its actions under the authority of its own Ministry.

When required, each administration can provide the assistance of its assets as part of the State Action at Sea.

Tasks covered by the State Action at Sea

- Search and rescue and assistance to ships in distress :

- protection of life and property at sea ;
- maritime safety (technical control, nautical information).



- Public Authority :

- state sovereignty and protection of national interests ;
- maritime security (counter-terrorism, counter-piracy, public order) ;
- fiscal, customs and economic police at sea ;
- Combat illegal activities at sea.

- Environment :

- protection of the environment ;
- monitoring of maritime protected areas.



- Working conditions at sea & sanitary control.

- Management of maritime heritage & of public marine resources.

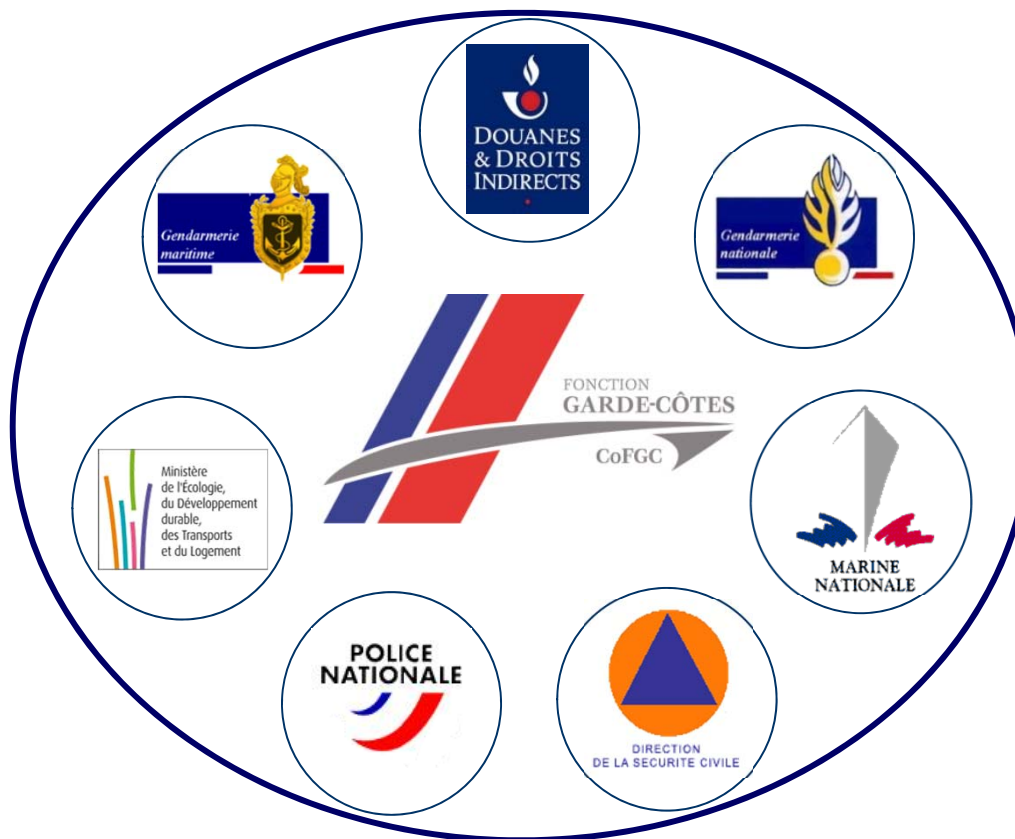

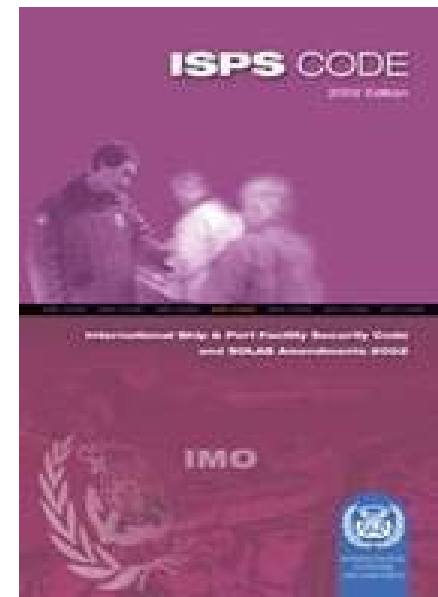
Safety & Security issues

Conference IMO 12 december 2002:

- Chapter XI-2 SOLAS : “Mesures to strengthen maritime security”.
- International Ship and Port Facility Security, in force since 01 July 2004.

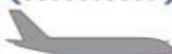
