2005 Counter-Terrorism Action Plans

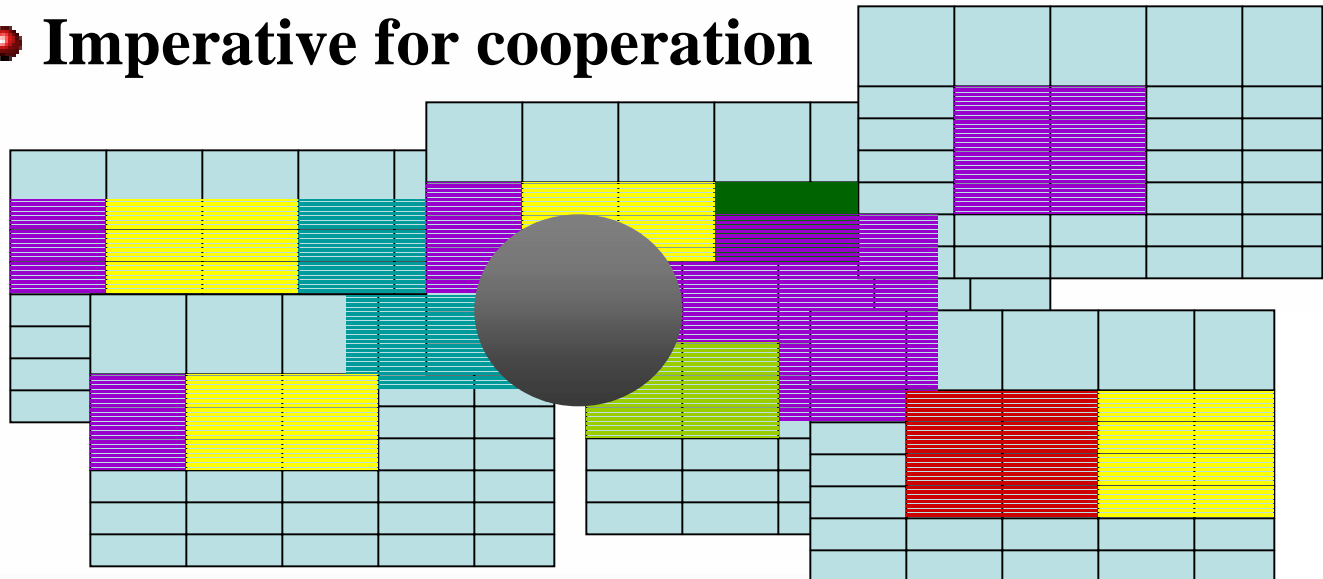
[Checklist of measures APEC economies have agreed to put in place]

- Issuance of Machine-Readable Travel Documents
- Cooperation on Imported/Exported Goods to Prevent Disguise of Hazardous Materials
- Strengthening of Public Health System

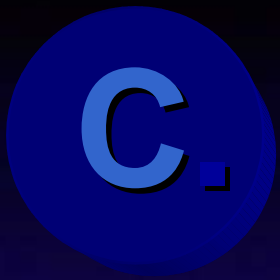
Cross-Analysis of CTAPs will show:

PROGRESS ON THE COUNTER-TERRORISM ACTION PLANS CROSS-ANALYSIS

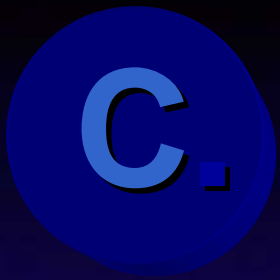
-

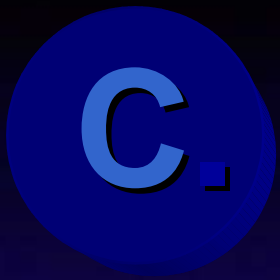


Continue Action on Key Deliverables

- Increased sharing of expertise between economies



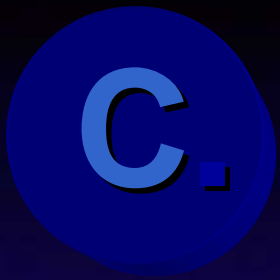


Continue Action on Key Deliverables

- Passing of domestic counter terrorism legislation



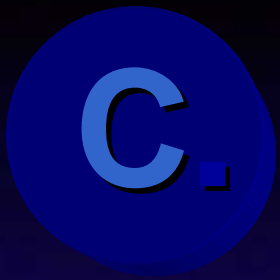


Continue Action on Key Deliverables

Continue Action on Key Deliverables

● *Enhancement of travel security*

- Cooperation on adoption of MRTDs, with biometrics
- Accelerating effort at replacement of non-MRTDs with MRTDs on best endeavor
- Facilitating implementation of ICAO travel document security standards
