### The Challenge: Donald Trump's Inauguration Speech



"Protection will lead to great prosperity and strength...two simple rules: buy American and hire American"

"We must protect our borders from the ravages of other countries making our products, stealing our companies and destroying our jobs".

## **Donald Trump on NAFTA**



"We're going to renegotiate NAFTA, **probably the worst trade deal ever agreed to**, signed, in the history of the world....If we don't get the deal we want, we will withdraw from NAFTA and start all over and get a much, much better deal than we ever had before."



#### Significance of NAFTA Changes

- Focus of Possible Changes: Rules of Origin; Dispute Settlement
- Impact on Canada and Mexico (Integrated Supply Chains)
- Supply Management in Canada and Softwood Lumber likely targets
- Impact on US Economy
- Impact on other US trading partners



## **Donald Trump on TPP**

"The Trans-Pacific Partnership is the greatest danger yet. The **TPP**, as it is known, would be the death blow for American manufacturing. I'm going to issue our notification of intent to withdraw from the Trans-Pacific Partnership, a potential disaster for our country".



#### Impact of TPP "Demise"

- Knock on effect on trade liberalization initiatives in the region (what happens to TPP consensus on a range of issues?)
- TPP Minus One-a realistic possibility?
- Positive or negative impact on RCEP?
- What happens to US engagement in Region?



## **Donald Trump on China**



"China's entrance into the World Trade Organization has enabled the **greatest job theft in the history of our country.** I'm going to instruct the U.S. trade representative to bring trade cases against China, both in this country and at the WTO."

#### US-China Trade (& Political) Relations: Potential Impact

- Imposition of border measures (the infamous 45% tariff), leading to retaliation?
- Investment and currency issues (Impact on FDI both ways)
- China as a leader of globalization? (Xi Jinping 's Davos Speech)
- Strategic/political fallout of a "trade war"



#### The Realities Behind the Trump Rhetoric

- Slowing growth globally
- Uneven distribution of benefits of trade within economies
- Automation; changing nature of jobs and the workforce
- Lack of open trade champions



#### Canada's Response

- Renewed Commitment to Open Borders
  - Successful conclusion of CETA
  - Offer of constructive engagement with US on NAFTA
  - Dialogue with Mexico (avoid hub and spoke with US)



#### Canada in Asia: Post TPP




- Renew bilateral FTA talks with Japan
- (but is Japan interested?)
- Pre-FTA negotiations with China
- Feasibility study with ASEAN
- Ongoing negotiations with India



#### Canada-Asia Investment Flows

- Steady growth in two-way investment
- Significant Asian investment in Canadian energy (China, Malaysia, Korea, Japan, India, Australia, Brunei
- Canadian presence growing in Asia (Manulife, Sun Life, Bombardier, CAE)
- Canada (finally) joins AIIB





### Canada's Bilateral Trade in Goods, 2015

Of Canada's top 6 trading partners, 5 are in Asia-Pacific

(with lots of room to grow!)
